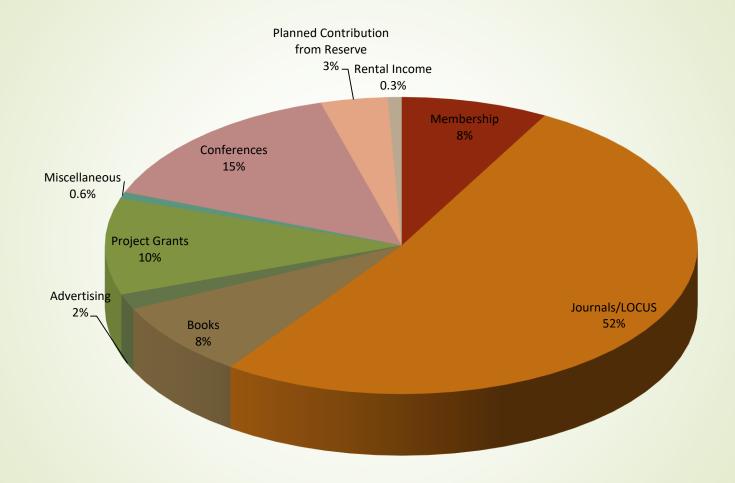

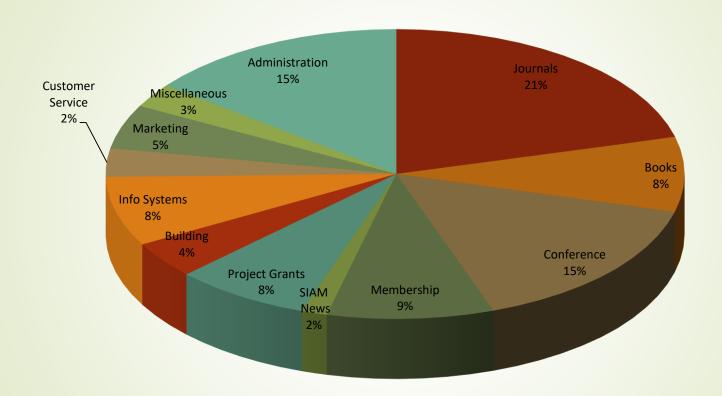

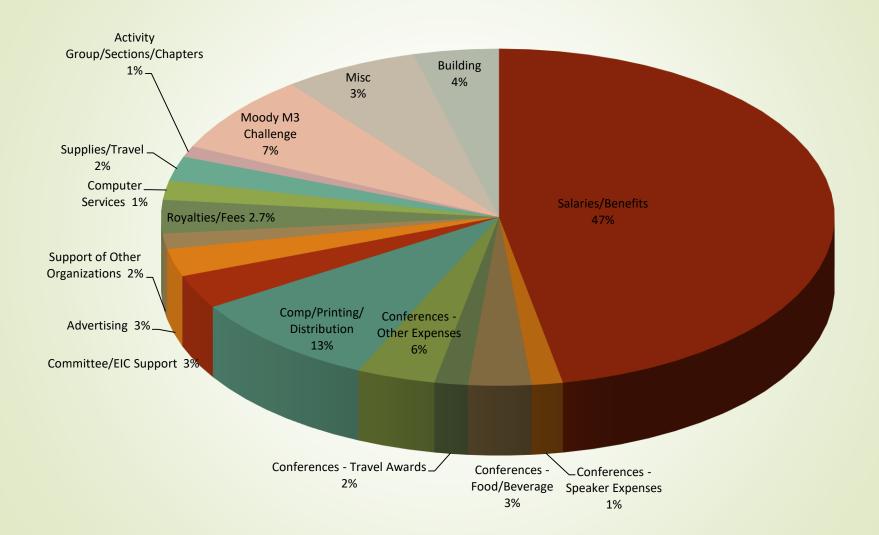
2016 Revenues



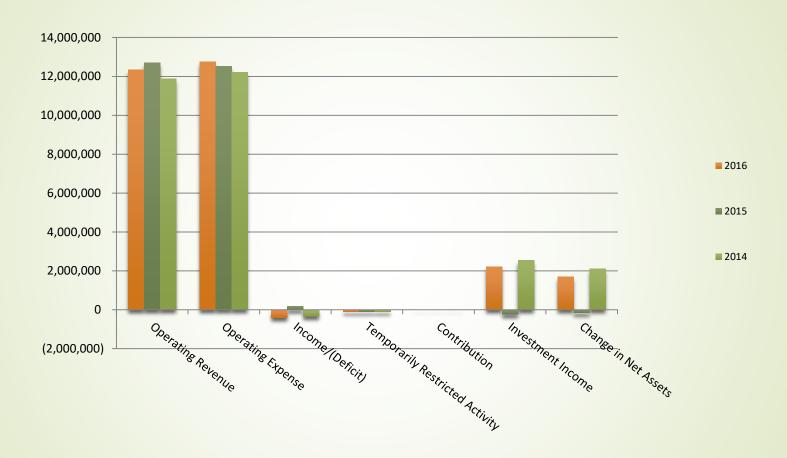
2016 Expenses
